- Clinical care for survivors in Ukraine: Medical and psychological care units are usually located at multidisciplinary hospitals, have medical equipment, diagnostic kits (or rapid test systems), medicines, etc. for protection of reproductive health, HIV prevention, treatment of sexually transmitted diseases, prevention of unwanted pregnancies and provision of emergency care to victims of rape. There are 17 such units in Ukraine. Six of them are in the Donetsk Oblast, 5 - in the Luhansk Oblast; others are located in Vinnytsia, Mykolayiv, Kharkiv, Kryvyi Rih, Odesa and Kherson. Each unit provides 24-hour free assistance on the basis of anonymity. In addition, most of them have a separate entrance. [Source: UNFPA]. At time of writing, availability is limited particularly in Eastern and Southern Ukraine due to the emergency.
- Crisis rooms for women experiencing domestic violence were created in 2021 in Lutsk, Ternopil and Chernivtsi with support from the UNFPA Equality Springboard Project and funding from the Government of Sweden. The crisis rooms are temporary accommodation for women and their children, with a kitchen, furniture, utensils and food, operated by local social welfare centers. Further information here
- UNFPA has launched 24 mobile teams to provide social and psychological assistance to gender-based violence survivors and internally displaced persons who have fled war-torn zones. The mobile teams are launched by UNFPA, in coordination with the Office of Deputy Prime Minister of European and Euro-Atlantic Cooperation and the Ministry of Social Policy of Ukraine with implementing partners -NGO "Faith, Hope, Love", Charity Foundation "Smile UA", Youth Charitable Foundation "Initiative" and Charity Foundation "Butterfly". The mobile teams include psychologists, social workers and others who can visit women and families in their homes to provide critical services. Mobile teams will operate in 12 cities of Ukraine - Zaporizhzhia, Dnipro, Poltava, Odesa, Vinnytsia, Uzhhorod, Ternopil, Chernivtsi, Khmelnytskyi, Lviv, Lutsk and Ivano-Frankivsk. There are 2 teams in each city.

#### GBV AoR update note:

Women and girls continue to face severely heightened risks under the current conditions. Forced displacement, the division of families, accommodation in temporary or shared shelters, increased military presence and the establishment of checkpoints all heighten risks of Gender-Based Violence (GBV), which comes on top of an already high pre-existing prevalence in the country. GBV actors are receiving reports of sexual harassment and violence during displacement. Women and girls travelling alone are at increased risk of sexual exploitation and human trafficking. Difficulties in accessing basic goods and services, and lack of access to safe shelter, render women and girls extremely vulnerable to sexual exploitation and abuse. Direct humanitarian assistance is essential to meet the immediate needs of women and girls and reduces the risk of GBV. Risk mitigation of GBV must also be integrated as a priority across the humanitarian response.

GBV actors on the ground report that although specialized services - including GBV hotlines - remain partially functional, access is extremely difficult for both staff and survivors due to ongoing conflict and movement restrictions, including the blockage of some passages by Improvised Explosive Devices (IEDs).

Service mapping is being updated and new referral pathways will be developed for key locations where the humanitarian response was not previously operational, in particular areas with a sharp increase in the displacement of women and girls.' [GBV AoR update released on 11 March 2022].
