Introduction

This query report provides a summary of the recent Disability Donor Landscape Mapping, commissioned by FCDO, which mapped current donors and funders globally that have a focus on disability inclusion, in June 2025. These include bilateral and multilateral donors, private sector actors, philanthropic donors, foundations, and high-net-worth individuals. The report provides an overview of current donors who are currently engaged with disability inclusion and what they are funding.

Summary of Findings

- > The donors reviewed show strong interest in funding diverse population groups, with a strong focus on gender, children, and youth.
- > Disability inclusion is a common interest, but funding is often limited, especially from some multilaterals (e.g., African Development Bank), private foundations, and philanthropic funds. Focused disability funding exists but is usually small, fragmented, and spread across multiple donors.
- > There is very little focus from donors on LGBTIQ+ disability inclusion.
- > The main target group for most donors is women and girls. Other groups are included intersectionally through cross-cutting thematic areas, such as education or economic empowerment.
- > Accessing foundation and fund support often requires pre-existing relationships, making fundraising costly and inefficient for Civil Society Organisations and disability-focused organisations.
- > There is need for more donor dialogue and collaboration to improve the transparency, accessibility, and cost-effectiveness of disability inclusion funding.
- > There is very little information available on the engagement of high-net worth individuals and families with disability inclusion, including their level of interest or appetite for funding disability-inclusive programmes.
- > It is important to flag that this mapping document is a snapshot of a rapidly changing donor landscape, so the evidence presented is not full or final. On-going mapping should be undertaken at regular intervals to ensure that this document is a work in progress to stay as up

to date as possible.

Bilateral and Multilateral Banks

The Bilateral and Multilateral Banks have overlapping thematic focuses and operate across different regions with different population groups. Most of the Banks have a specific focus on advancing gender equality and disability inclusion through their policies and programmes, however a few, such as African Development Bank (AfDB) and International Monetary Fund (IMF), only focus on gender equality with limited support to people with disabilities or other marginalised groups. The bullet points below show which Banks are involved in different thematic sectors.

Funds and Philanthropy

Various funds that were explored have a focus on gender equality, disability inclusion, and inclusion of other marginalised communities, including indigenous people, youth, racial minorities, LGBTIQ+ people (such as Global Greens Grants Fund, Ford Foundation, Wellspring Philanthropic Fund, the Disability Rights Fund, and the Gates Foundation). The bullet points below show which funds and foundations are involved in different thematic sectors:

Business Donors, Corporate Social Responsibility, and Corporate Foundations

Most business donors or corporate foundations include disability inclusion within their hiring and employment practices, with some providing grants or funds that support disability inclusion (such as Lego Foundation, Standard Chartered Foundation, Lloyds Bank Foundation and Lloyd's of London Foundation, ILO Global Business and Disability Network, Primar, and Adobe). Some also focus on youth employability and supporting disadvantaged

young people, women's economic empowerment and addressing systemic inequalities. Below is a list of the thematic areas that different business donors and corporate foundations focus on:

- > **Lego Foundation:** Inclusive education (including Education in Emergencies); Early childhood development (through play); Disability inclusion; Child and youth rights.
- > **Standard Chartered Foundation:** Disability inclusion; Child and youth rights; Addressing inequalities and social impact; Women's economic empowerment; Youth employment and skills; Financial inclusion.
- > **Lloyds Bank Foundation & Lloyd's of London Foundation:** Disability inclusion; Addressing inequalities and social impact; Inclusive research; Capacity building.
- > **ILO Global Business and Disability Network:** Disability inclusion; Accessible workplaces; Corporate Social Responsibility; Private sector development; Sustainability and climate change/justice.
- > **Accenture:** Disability inclusion; Addressing inequalities and social impact; Youth employment and skills; Capacity building; Accessible workplaces; Corporate Social Responsibility.

High-net-worth individuals and families

Information about high-net-worth individuals and families, and their pledges to fund development initiatives, is minimal. However, the full report did look at a variety of such donors and found some pledges to disability inclusion, youth wellbeing, medical research, supporting locally led development and capacity building of grassroots organisations, and governance and democracy, to name a few. Some individuals have pledged to put a significant portion of their wealth to charitable causes, for example John Cauldwell pledging 70% of his wealth and Robert Bosch Stiftung funding €100 million. The below highlights the findings:

- > **John Cauldwell:** Children and youth; Disability inclusion; Mental health and wellbeing; Medical research.
- > **Ansara Family Fund:** Disability inclusion; Global poverty; Social justice; Locally led development; Building capacity; Health (equity); Energy and infrastructure; Sustainable livelihoods.

About Helpdesk reports: The Disability Inclusion Helpdesk is funded by the UK Foreign, Commonwealth, and Development Office (FCDO), contracted through the Disability Inclusion Team (DIT) under the Disability Inclusive Development Inclusive Futures Programme. Helpdesk reports are based on between 3 and 4.5 days of desk-based research per query and are designed to provide a brief overview of the key issues and expert thinking on issues around disability inclusion.
